My wife and I, along with several of our friends, developed donation centers and drop-off points throughout central Ohio, coordinated with shelter intake personnel, arranged publicity, organized teams of volunteers to sort and pack, secured in-kind packaging and shipping donations from UPS and Victoria's Secret, and ultimately delivered 5,000 stuffed animals in a convoy of dedicated UPS trucks to shelters in the hardest hit areas along the Gulf).
